Innovations or New Practices in Election Administration

Summary: Transparency = Confidence

Prince William County was the first county in Virginia and one of the first in the nation to publish all officer-signed results tapes online, giving the public access to primary sources of election results.

In recent years, concerns about election integrity have been voiced regarding the accuracy of results, effectiveness of voting machines, etc. The most effective way to combat disinformation and concerns at the local level is to provide heightened levels of transparency that allows the public access in new and unprecedented ways.

This has two significant impacts – (1) it builds confidence by allowing skeptics to access the source of concern and (2) the act of supplying public access to such data/ documentation builds confidence even if never acted upon.

While the public having the ability to verify a particular precinct's results match the reported totals is valuable as a validation test, the confidence gained in the knowledge it is available is just as meaningful, if not more so.

Creativity and Innovation

Posting results tapes online is simply applying a cost-effective tool (scanning documents) to the primary documentation of election results (results tapes) in a way not previously utilized.

While results are reported online on state and local websites and consequently through the media on election night, the public does not generally have access to the reports or the sources of that original data. It is taken on faith that the results the officers oversee are accurately being translated to those larger pools of data.

While this is true 99.9% of the time, providing tools to allow the verification of the data allows the public to have 100% confidence in those results.

ORIGINAL DOCUMENTS

Below are the original documents including the tally tapes (from the ballot scanners) and hand count forms (used to count ballots that cannot be scanned) returned from the bipartisan election officer teams at the polling places. They are returned under seal and opened by a review team who verifies the precinct results against those reported on the Virginia Department of Elections website. These documents are then available for public viewing.

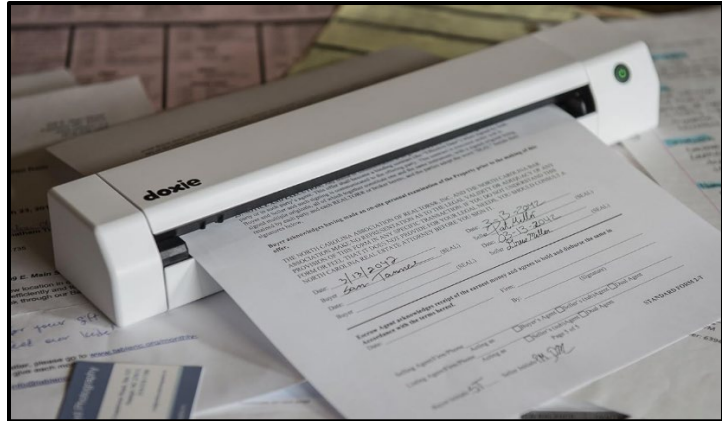
The results are in number order by precinct. Use the arrows by the page number designation at the bottom of the table to move through the results. If a precinct used a second scanner or conducted a hand count, that will be noted in the Results column, and a scan of those results is included as an additional page(s) in the Results PDF document.

Can it be Replicated

Yes, while the approach itself is novel, the execution of publishing results online is very easy and straightforward. A few states may have laws that prohibit the publishing of these documents, but most do not. With a slight modification to the post-election process, any county or state could easily add this as a feature to their web site.



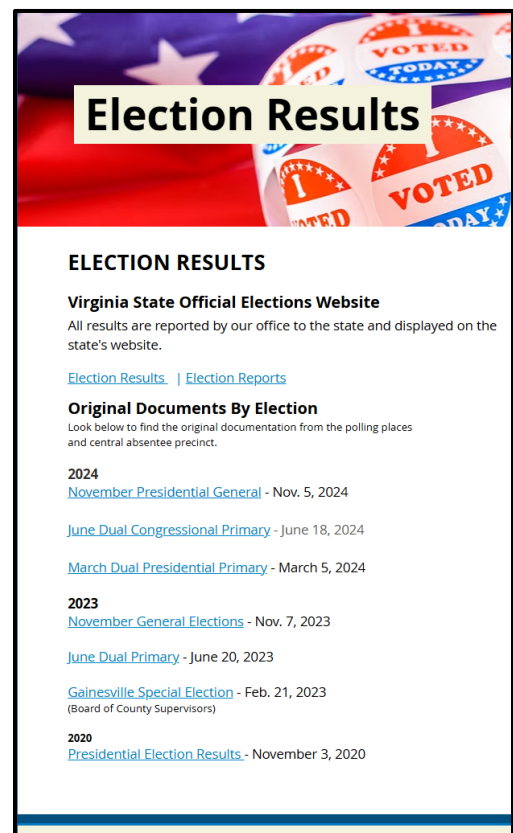
Meets Category Requirement

This program is emblematic of this category because it is simply looking at a way of doing things differently.

Organizations typically focus on what they do and how they do it, but the real question is why - **why is our procedure built this way?** While there may be valid historical reasons, people, environments, and organizational needs evolve. Processes must evolve in step with those changing needs.

While publishing results tapes online may not have been necessary or feasible two decades ago, whether due to cost or lack of technology—those limitations have changed. Today, there's no reason any organization shouldn't embrace this simple yet powerful practice.

The principle of examining how you do things is as important in this instance as the actual result.



Outcomes for Voters/Election Officials

This program has been beneficial for voters as it allows them to audit election results and have confidence in the transparency in the PWC Office of Elections.

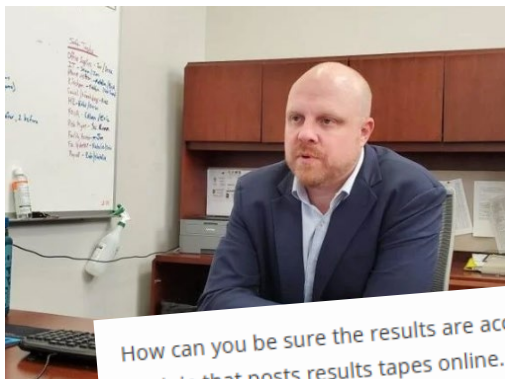
For election officials, not only does it alleviate concerns and skepticism regarding elections, but it has saved time and money. FOIA requests dropped from 123 in 2023 to only 88 in 2024 despite the latter being a presidential election year. That is a nearly 30% drop in FOIA requests and allows our staff to focus their time and attention on assisting voters.

Our office has increasingly moved documentation online for public use. In addition to results tapes being posted online, officer manuals, Board policies, FOIA policies, and more have all migrated to public view.

I would encourage every county to pursue this practice and to think of ways this approach could be expanded. Election offices around the country do excellent work and administer accurate and fair elections. There should be no hesitation in demonstrating that excellence for the public.
