### 1.5 Interest Accrued on Federal Fund in 2018

There was no interest accrued in FY2018. These funds were received on September 25, 2018, which represented only four (4) of the 28 days of interest accrual.

### 1.6 State Match Share

Alabama's Required State Match Share was determined to be \$308,020. The State Match Share will be satisfied by replacing and upgrading certain voter registration equipment used by certain state election officials. The state commenced, on the effective beginning date of the grant on March 23, 2018, meeting this obligation. Since March 23, 2018, the state has expended, with state funds alone, \$9,899.30 in printers, printer repair parts, printer maintenance kits, and barcode scanners and supporting hardware.

#### 1.7 Other

The Title 1 Section 101 (Election Security Grant) funds are relatively new and the state is continuing its planning protocols to utilize the grant. The state expects to begin expending the funds in FY2019.
